Plan Summary [2022-2023]

General Information

A description of the LEA and its students

Irvine International Academy Charter School is a Mandarin immersion public charter school located in Irvine, California, serving approximately 307 students in grades K-5. Student demographics include: ~75% Asian, ~11% 2+ Races, 2.6% White, 5.1% Hispanic, of which, 20.3% are English Language Learners (ELL), 4.8% on Free/Reduced lunch, and 14.1% foreign born students.

Irvine International Academy's (IIA) educational model integrates a Mandarin Language Immersion educational framework within a State Standards-aligned curriculum ensuring that our students are prepared to excel and prosper in the 21st century. IIA aligns with this curriculum by delivering state standards through a one-way 50:50, Mandarin/English immersion model.

The proportion of instruction in Mandarin and English may shift gradually as students move up in grade level. Transitional Kindergarten (TK), Kindergarten, and 1st grade students spend 50% of their time exclusively immersed in Mandarin, while 50% of the content delivered in English. Subjects taught in Mandarin is taught by bilingual teachers with native proficiency in Mandarin. However, the lower grades (TK-4) may increase Mandarin instruction time to meet the school's goals.

IIA creates a progressive learning environment for TK through 6th grade students, preparing them to be lifelong learners. English and Chinese are spoken by a substantial number of individuals around the world. IIA believes that this pairing of two languages will allow our students to become more familiar with and be able to navigate various cultural situations with much more ease – the definition of the Global Citizen. IIA provides a bilingual and bicultural education that promotes high academic achievement and cultivates students' social emotional intelligence and curiosity, equipping them with 21st century learning skills to thrive in our dynamic global society. IIA aligns with the state initiative to equip students with world language skills to better appreciate and more fully engage with the rich and diverse mixture of cultures, heritages, and languages found in California and the world.

To capture the full range of abilities and talents that students possess, we differentiate learning to meet individual student needs through different approaches. These are the following: Linguistic, Logical/Mathematical, Spatial, Musical, Bodily/Kinesthetic, Interpersonal,

Intrapersonal, and Naturalist intelligences. In addition, students participate in a learning environment that encourages intellectual risks and higher-level thinking. Creative, problem-solving skills are practiced in the classroom, and Bloom’s Taxonomy is used (or will be used) to establish critical thinking objectives to plan lessons, assess learning, and ensure instruction and assessment align.

The California School Dashboard (Dashboard) is an online tool that shows how local educational agencies and schools are performing on the state and local indicators included in California's school accountability system. The Dashboard provides information that schools can use to improve. The Dashboard is made up of reports that show school performance on six state indicators. The state indicators are based on data that is collected consistently across the state from LEAs through the California Longitudinal Pupil Achievement Data System (CALPADS) and testing vendors. The state indicators are: academic (English and Math), English Learner Progress, Chronic Absenteeism, Graduation Rate, Suspension Rate, and College/Career Readiness.

Performance levels for Chronic Absenteeism and Suspension Rate reflect <1% school wide. Our students are performing at high levels for English Language Arts and Mathematics. The ELA & Math Academic Indicators (Star Renaissance Testing metric) reflect a ~90% average of students meeting/exceeding grade level competencies school wide.

IIA has an informal assessment for Mandarin, using Mandarin report cards. In addition, cultural competency is measured through holidays, cultural events, and extracurricular activities.

Although informal assessments indicate strong progress in Mandarin Chinese, a more standardized metric is necessary. The school curriculum plan requires more support for teachers to conduct formal language assessments in this area

Stronger support of ELL students is also required, and moreover, teachers need more student behavior support.

IA Implemented Positive Behavior Intervention Supports (PBIS) during the 2021-2022 academic year, and will continue to focus on the implementation of Academic Interventions.

Teachers, Administration, and Student Success Team (SST) Team, collaborate to ensure the effective implementation of our referral processes in place and updated as needed.

During the 2021-22 school year, members of our staff/Leadership Team consulted with stakeholders to discuss components of our LCAP on a regular basis IIA benefited from significant and purposeful engagement of stakeholders. The general board meetings were held on the last Tuesday of every month. The general finance committee meetings were held every month. The School Site Council met regularly; all these meetings discussed and approved the goals of the LCAP and proposed uses of funds.

- Administrators and staff would like to continue to strengthen socio-behavioral supports, social-emotional support, and academic supports in the classroom to accelerate learning.
- Teachers indicated there was a need to continue with various tiers of intervention and instructional support.
- Parents indicated they were concerned with curriculum development and Mandarin assessments.

Introduction and Instructions

The Local Control Funding Formula (LCFF) requires local educational agencies (LEAs) to engage their local educational partners in an annual planning process to evaluate their progress within eight state priority areas encompassing all statutory metrics (COEs have 10 state priorities). For example, if an LEA determines that low-income students have a significantly lower attendance rate than the attendance rate for all students, it might justify LEA-wide or schoolwide actions to address this area of need in the following way:

After assessing the needs, conditions, and circumstances of our low-income students, we learned that the attendance rate of our low-income students is 7 percent lower than the attendance rate for all students. (Needs, Conditions, Circumstances [Principally Directed])

In order to address this condition of our low-income students, we will develop and implement a new attendance program that is designed to address some of the major causes of absenteeism, including lack of reliable transportation and food, as well as a school climate that does not emphasize the importance of attendance. Goal N, Actions X, Y, and Z provide additional transportation and nutritional resources as well as a districtwide educational campaign on the benefits of high attendance rates.
